**ASR ADR Process – Periodic Report**

Dear Mr Justice Coffey

We write once more on behalf of DePuy pursuant to Clause 2.2 of the ADR Process, ahead of the Court's review of the ADR Process, which is listed for hearing before you on Tuesday, 3 June 2025. This is the 21<sup>st</sup> update to Court on the ADR Process. We are sending a copy of this letter by email today to all Plaintiffs' solicitors involved in the DePuy litigation and to the Chairman of the Evaluators. We will also put a copy on the ADR website ([hipadr.ie](http://hipadr.ie)), which is regularly updated by us on behalf of DePuy.

**Summary of ASR litigation**

1,173 High Court proceedings relating to the ASR prosthesis have been issued against DePuy. The cases break down as follows:

- 1000 are resolved (including 65 in 2025).
- 47 are currently in the ADR Process.
- Outside of ADR, there are 73 claims involving revised Plaintiffs which are not resolved; and
- There are 53 remaining claims involving unrevised Plaintiffs.

There are no cases listed for hearing in 2025.

### **Update on ADR Process**

Since the inception of the Scheme, we have received 305 Form Bs from 96 different solicitor firms and we have resolved 238 of those claims. 129 claims have been evaluated and we are expecting 2 more evaluations to be made.

Submissions have been filed by both parties in respect of 4 further cases and we now await the Plaintiff's further replies to DePuy's submissions in 2 of those cases. We are also awaiting confirmation as to the Plaintiff's intention to prepare replying submissions in 1 further case. In 1 case, the Plaintiff has confirmed their intention to file a further report.

DePuy has received Plaintiffs' submissions in 2 cases since the last report to the Court.

While DePuy has rejected 16 evaluations, all but 3 have been resolved. Only 5 claims remain unresolved where a Plaintiff rejected the evaluation.

Of the 75 claims where a Form B was submitted, but had not been endorsed, 47 were resolved before endorsement and 22 were ineligible under the terms of the ADR Process. Of the 6 other claims that have not yet been endorsed, we either await further medical records, details of special damages or other information, before being able to determine eligibility.

There are currently 41 endorsed claims in the ADR Process that have not yet resolved. The cumulative numbers for the ADR Process at each review date are recorded in the appendix hereto.

### **Exclusionary criteria in ADR**

Two cases have been deemed ineligible for ADR since our last report.

### **Priority cases**

We give urgent attention to any case where the Plaintiff's solicitor marks the claim as "*expedited*" on the Form B. The Court has also said that it will hear applications for trial dates in exceptional cases.

### **Medical records**

Where records cannot be found, or where Plaintiffs' solicitors are encountering other difficulties retrieving medical records, we discuss with them how the problem can be overcome. We also offer to collect medical records without expense to the Plaintiff, in cases that appear eligible for the ADR Process and where the Plaintiff's solicitor gives us authorisation(s) signed by the Plaintiff and addressed to the medical service provider(s). We copy collected records to Plaintiffs' solicitors.

### **Costs in ADR**

The offer of €25,000 in respect of a Plaintiff's legal costs on account for any case resolved within the ADR Process remains available. The offer is without prejudice to the right of a Plaintiff to seek higher costs by agreement or, if necessary, on adjudication.

### **Staffing for ADR**

One Partner, one Consultant, two Senior Associates, one Associate and two legal executives at McCann FitzGerald work on claims in the ADR Process. These solicitors, together with Barristers

retained on behalf of DePuy in the litigation, are available to discuss with Plaintiffs' lawyers resolution of any eligible claim.

**Information to Plaintiffs' representatives**

We continue through the ADR website, [hipadr.ie](http://hipadr.ie) to draw the attention of Plaintiffs' representatives to the ADR Process and to our client's willingness to discuss resolution of all eligible claims.
